Each year during the month of May, we reflect upon the tragic loss of life sustained by our Law Enforcement family. Nationally, during calendar year 2014, one hundred twenty six (126) officers were killed in the line of duty.

On May 1, 2015 the 29th annual Maryland Fallen Heroes Day will be observed at Dulaney Valley Memorial Gardens. The staff at Dulaney Valley Memorial Gardens are committed to honoring Maryland's Public Safety Officers who lost their lives in the line of duty, as well as providing comfort and support to their families. Seven of the nine fallen heroes from the Baltimore County Police Department are interred at this location.

The Baltimore County Police Department will honor its fallen officers on May 8, 2015, at our Police Memorial in Towson. Please remember these officers and their families in your thoughts and prayers.

On May 15, 2015 the National Peace Officer's Memorial service will take place in our Nation's Capital. Tribute will be paid to our fallen colleagues for their acts of courage and heroism.

Never forget their passion for making this county, state, and nation a better place in which to live. Never forget their commitment to the Constitution of the United States of America, and to the enforcement of our nation's laws. Continue the work they started; support their families, and each other in their loss. It is our sustained diligence to the profession of law enforcement that validates the sacrifice of our fallen comrades.

- The County filed for a Writ of Certiorari to the Maryland Court of Appeals in the retiree health care subsidy case on January 30, 2015. The Court does not have to choose to hear the case. We will inform the membership of any update from the court. The reimbursements will remain in escrow until the case is finished.
- In the Brandt Bradford case, the ERS/County has filed an appeal to the Court of Special Appeals. No briefing schedule has been set.

LEGISLATIVE COMMITTEE

- There were 17 Bills introduced in the House of Delegates which would have altered the LEOBR and a few on body camera's. The attack came from the Mayor and some Delegates from Baltimore City. FOP leaders throughout the state have worked very hard meeting delegates and senators to defeat the bills.

PENSION COMMITTEE

- At the March Pension Board of Trustees meeting the Board approved 21 total retirements. One of those was from the police department.
- Council Bill 11-15 was enacted by council at the March meeting. This raises the number of pension board members from 8 to 11. The Bill allows for two additional members to be appointed by the County Council and one additional member to be appointed by the County Executive. The appointed members must be County residences and cannot be employed, hold an

elected office or appointed position with the county or state. In addition, the members cannot be beneficiaries of this retirement system or any other retirement system in the state. They must have knowledge and experience in the administration and operation of pension systems, investments or trust funds. The terms will be for four years.

- The board members voted to delay the decision to reallocate any funds in the system until the new members could attend and provide input.

POLICY REVIEW COMMITTEE

- In January, the Department convened a Body Worn Camera Workgroup at the direction of the County Executive. The Committee has concluded and a report is being drafted for the committee members to review and approve before it is submitted to the Chief.

- Patrol Vehicles-no reported safety issues were found with the passenger compartment in the Ford Taurus.


NEW BUSINESS
