The Coronavirus Disease (COVID-19) continues to impact our daily lives, but we at FOP Lodge #4 remain committed to supporting our members. As first responders, our duty to service means placing ourselves at the frontline of response efforts and increasing our own risk of exposure to this worldwide health pandemic.

As we strive to meet this challenge, we encourage you to take every precaution possible to ensure the continued health and safety of you and your families. Remember to use the Personal Protective Equipment (PPE) even on the most routine calls and if you are not feeling well, please stay home. While you and your co-workers continue to demonstrate immense bravery through your service, remember that the most heroic step you can take to stop the spread is to stay home.

To help ensure our members have access to the equipment they need, FOP Lodge #4 recently accepted and distributed two donations of 500 N95 masks from Universal Packaging in Cockeysville as well as a donation of 3,000 surgical masks. As a lodge, we've also been doing our part to support the communities who have been most impacted by this pandemic. Our Executive Board of Directors unanimously approved a \$1,000 donation to the Baltimore County Response Fund to supply approximately 450 families with fresh food from local vendors.

With Maryland's caseload continuing to grow, so is our commitment to fulfilling our duties to precincts across Baltimore County. As president, I continue to participate in daily conference calls with Chief Hyatt, her Command Staff and the Incident Management Team and provide input and suggestions on behalf of the FOP. Our Lodge also assumed a local and statewide leadership role last week when we submitted a letter to Governor Hogan, County Executive Olszewski, Senate President Ferguson and House Speaker Jones requesting they declare any illness or injury related to COVID-19 a work-related presumption for worker's compensation. I have asked the Maryland State FOP Lodge, Baltimore County Firefighters Local 1311, and BCFPE LOCAL 4883 to join me in making the same request of our local and state leaders.

While we await their response and hopeful action, please keep personal documentation about the types of calls you respond to, the people you have had contact with, at work and in public, and your use of PPE. This will be your best protection and evidence in the event you have to file a COVID-19 worker's compensation claim.

The leadership of FOP Lodge #4 would like to extend our thanks and appreciation for your service, in these historic and unprecedented times. Should you or a family member be instructed to self-quarantine, know that we are here to help. LEGAL ADVISORY COMMITTEE ~Ryan Massey~

- The trial board for Sergeant Vicosa was held beginning on February 26, 2020.
- Sergeant Vicosa was found guilty on 5 of 6 charges.
- There are 3 additional hearing boards pending.

LEGISLATIVE COMMITTEE ~Dave Rose~

- The 2020 legislative session of the Maryland General Assembly adjourned on Wednesday, March 18, 2020 due to the COVID-19 pandemic. The presiding officers announced the early end to the session and that they plan to return for a Special Session at the end of May.
- In light of the abbreviated session we were successful in getting legislation passed that is important to our members across the entire state of Maryland. These bills were sent to the Governor for his signature.
- HB 276, expanding a subtraction modification under the Maryland income tax for certain officers to include law enforcement officers who are members of the Maryland National Capital Park Police.
- HB 588/ SB 587 providing that members of the State Police Retirement System no longer make member contributions after 28 years of service credit is earned, which is the maximum.
- HB 616/ SB 485 altering a certain authorization for certain Department Of State Police employees to work an alternative workday or a 40 hour civilian employee to work an alternative workday of not more than 12 hours instead of an 8 hour workday.

- Perhaps more importantly, we were able to successfully kill several pieces of legislation that would have had a negative effect on our members ability to do their jobs effectively and safely.
- President Rose along with several FOP members from across the state, as well as Mike
 Davey and Chaz Ball from
 SBWD, testified against legislation in Annapolis on March 3,
 2020. This testimony ran until
 8:30 p.m.
- President Rose, 1st VP Massey and our lobbyist John Stierhoff met with Senators Sydnor and Hettleman on March 9, 2020 to discuss our amendments to HB 1221/SB 1029.
- On Sunday, March 15, 2020, with the assistance from our lobbyist John Stierhoff and other delegates with whom we have a relationship, we were able to get HB1221, special ordered with amendments. This will essentially stop any further action on the bill in this abbreviated session. It will eventually be revisited if the session reconvenes or definitely next session. I would like to thank Delegate Jon Cardin and Delegate Robin Grammer for their assistance.
- As of the adjournment of the session, none of the following bills were passed. HB 1090 Anton's Law, changes the reasonable officer standard that was set by the Supreme Court in 1989, HB 1221/SB 1029 Personnel and Investigatory Records—Complaints against Police Officers, HB 1309 Use of Force, HB 1090 Use of Force and HB 166 Use of Force.
- Brother Al Barton testified along with State Attorneys and Maryland Chiefs and Sheriffs against HB 624/SB 593 Child

Interrogation Protection Act. This bill mandated restrictions as to when an officer could speak to a juvenile in reference to any crime.

MEMORIAL COMMITTEE ~Don Patterson~

 Due to the COVID-19 pandemic, Fallen Heroes Day, Baltimore County Police Memorial Day and the National Law Enforcement Memorial Day have all been postponed. A decision will be made at a later date if any will be rescheduled.

MENTAL HEALTH COMMITTEE ~Dave Rose~

There is no updates on this Committee. Chief Hyatt asked for 2 representatives from the FOP to be on the COVID-19 team. President Rose appointed 1st VP Massey and Brother Comegna.

NEGOTIATION COMMITTEE ~Dave Rose~

- The Negotiations Committee met with the County Administration on February 26, 2020 and discussed their proposals. We did construct a counter proposal and it was given to the County Administration on March 2, 2020.
- The County sent us their counter proposal on March 11, 2020. We in turn, sent it back to them with our revisions. No agreement was reached. However, discussions continue.

- We have selected an arbitrator, Keith Greenberg. Arbitration was scheduled for March 27, 2020. He communicated to us on March 16, 2020 that he did not see how we could have the hearing on that date with the COVID-19 virus situation. He inquired about moving deadlines. However, our budget situation in the county would make that very unlikely.
- As of March 31, 2020, the FOP and the County Administration have not yet reached a tentative agreement on the July 1, 2020 through June 30, 2021 Memorandum of Understanding. We are still working hard to have one, as soon as there is one we can accept.

PENSION COMMITTEE ~Dave Rose~

- At the March 10, 2020 Pension Board of Trustees meeting, the trustees approved twelve (12) total retirements, none from the Police Department.
 - The pension system had an actuarial return for calendar year 2019 of 6.2%. The 8 year geometric average return, which is the method used to calculate a COLA was 7.5%. The Post Retirement Income Fund (PRIF) receives excess earnings over 7.875% to fund the account. The amount necessary to fund a 1% COLA is approximately \$19 millon dollars. The current balance on the account is \$1,795,000.00. Therefore, there will not be a retiree CO-LA on July 1, 2020. A letter is being drafted to all retirees.

POLICY REVIEW COMMITTEE ~Dave Rose~

- The committee reviewed two new or revised policies and identified no bargaining issues with any of them.
- I have been involved and/or had input in most of the COVID-19 orders.
- The Taser policy has several logistics that have to be worked out and discussed with the FOP. I have sent notice to Planning. I also met with the Executive Director of Training, Dave Anderson. A committee is being put together to work on where equipment is best placed on the new vest carrier along with the gun belt. This is on hold for now.
