50th Anniversary of Baltimore County Lodge No. 4

This year we celebrate our golden anniversary. On December 3, 1970, thirty-two members met, founded, and chartered Baltimore County Lodge No. 4, of the Fraternal Order of Police.

The Lodge has fought for many benefit improvements for our members in our 50-year history. Two of the biggest milestones for the membership was the passage of the Baltimore County Collective Bargaining Bill which was signed into law in 1977. The Lodge became the exclusive bargaining agent for all Baltimore County police officers through the rank of lieutenant. Our first Memorandum of Understanding with the County was signed on August 8, 1978. Starting salary was \$12,111 and a twenty-five-year officer salary was \$18,199.

In 2002 Lodge #4, in a joint effort with Baltimore County Fire Fighters Local 1311, secured Binding Arbitration through the passage of a referendum question on the November 2002 ballot.

Lodge #4 members purchased our first permanent office on January 14, 1983. The original building located at 9304 Harford Road, Carney, MD, served the membership for 15 years. The current Lodge building was built on the rear of the same site and was opened for business on April 28, 1998.

Over the last 50 years, Lodge #4 has grown to an actively employed and retired membership today of 3,164. Together we have had many successes that would not have been possible without everyone's team effort and leadership.

I would like to thank all those members who have taken Lodge leadership roles over the past 50 years and who gave their time and talents along the way.

Thanks, also, to those members who supported the efforts of the Lodge.

We look forward to another fantastic 50 years!

HEALTH CARE COMMITTEE ~Mike DiCara~

In November, open enrollment for 2021 healthcare coverage continued. Printed materials have been mailed to all active and retired members explaining the changes to their plan offering. Numerous members have contacted the Lodge for guidance through the new process, particularly retired members who are Medicare eligible. These members have overwhelmingly reported a positive experience with Labor First, and have been directed to a plan that is most cost effective for them while still maintaining or increasing their current benefits.

LEGAL ADVISORY COMMITTEE ~Ryan Massey~

- The Corporal Galloway trial board was held on November 10, 2020. He was found guilty on two counts. Legal Director Hill posed a punishment of not being eligible to be promoted for 3 years. The Board voted 2 to 1 against as excessive due to the fact the Chief can decide whether to promote or not.
- The Corporal Brennan trial board has not yet been scheduled. There are also pending trial board on POFC Workenauer and POFC Allen.
- Marvin Haw case is to be scheduled in front of the Pension Board of Trustees. Updated rec-

ords were added to the case file from expert witnesses.

LEGISLATIVE COMMITTEE ~Dave Rose~

- Councilman Jones introduced a bill to adopt rules limiting "no-knock" warrants in County Council on October 5, 2020. A hearing was scheduled for October 27, 2020 with a vote on November 2, 2020. The FOP opposed the bill as written. The department already has very stringent policies on this type of warrant. The bill was withdrawn on October 22, 2020.
- Our lodge is continuing work to educate the legislators and public on what we do and the training we receive. Right now, there is a lot of misinformation out there about how policing is conducted in Baltimore County. That needs to be addressed. The agency has offered some training at the Academy and has invited many legislators to take advantage of it and see what our members face daily. Several legislators have taken advantage of that training.
