Brothers and Sisters,

We have learned that our data system has been hacked by an unknown individual or group. It appears to have originated outside of the United States. The data breach is a complete breach of our data including names and addresses of members as well as date of births and phone numbers. We do not collect Social Security information so that was obviously not available to the hackers.

We recommend that all members head the following advice:

FOP members should immediately stop using their FOP password and change the password on any business/personal accounts in which that password is reused.

FOP members should monitor their credit reports, financial, and tax statements for any unusual activity.

FOP members should take steps to secure/remove information about themselves and their family online, which could be used to draw connections with the compromised data to more effectively target victims with malicious activity.

The Executive Board has meet and we have authorized our Information Technology team and outside consultants to take whatever steps are needed to get the system back up and secure.

A MESSAGE FROM LODGE #4 PRESIDENT WESTON

Recently at FOP Lodge #4 we have upgraded our entire network and server system. Unlike the National FOP, member data is not stored on the same network (or server) as our website or email. So there is no public access to our server or network. The National FOP allows member access with a user ID and valid password. Our server is behind the Comcast router with a built-in fire-wall. Comcast randomly reassigns our public IP, so the IP we send out to the world today is different next week. We also added a domain service when we upgraded the server. One cannot get to any of our files without a valid login.

We have also taken the precautions of not allowing outside access to the network, requiring valid logins to access the network files, disabling the common default accounts, naming the internal domain separately from our email and website domains and not sharing access with guests.

While nothing is impossible to access, as we have seen in recent times, we feel we have taken appropriate precautions.

- Motions that were made, after receiving a proper second, were discussed, voted upon, and appear in this issue under the appropriate committee reports.

REPORTS OF COMMITTEES

GRIEVANCE COMMITTEE ~Dave Rose~

• On January 4, 2016 the post memorandums in our step #3 grievance over health care subsidy splits were submitted. We are waiting for a decision from hearing officer Stahl.

LEGAL ADVISORY COMMITTEE ~Dave Rose~

• The committee met to discuss two (2) cases in which we feel the County Administration has again ordered two (2) of our members to submit to illegal medical examinations in violation of the ADA. Our Attorney, Kathleen Cahill has reviewed both instances and advised the county is in violation of the ADA by ordering the officers to submit to further medical examinations even though the County's own physician has found both members to be fit for duty.

- The committee reviewed the recommendations and a motion was made to fund the action necessary to have the County's order rescinded and cease any further examinations. There was a proper second and the motion passed.
- The committee recommendation was presented to the Executive Board of Directors and the board accepted the committee's recommendation.
- The retiree health care subsidy case was presented at the Maryland Court of Special Appeals on November 9, 2015 and we are still waiting on a decision.
- The Brandt Bradford case was heard on February 8, 2016 at the Court of Special Appeals.

LEGISLATIVE COMMITTEE ~Cole Weston~

• The Public Safety and Policing Workgroup met on January 11, 2016 and the committee made 22 recommendations to the Senate and House leadership to put in the form of bills.

NEGOTIATION COMMITTEE ~Cole Weston~

• The negotiation team did not come to an agreement with the County and impasse was declared on February 1, 2016. • An arbitrator was selected and the dates for the hearing are March 18 and 21, 2016.

POLITICAL ACTION COMMITTEE ~Steve Comegna~

The Political Action Committee did not meet in January. Our 2016 Campaign Financial Annual Report was submitted to the State Board of Elections on January 5, 2016. The next report is due March 1, 2016.

PENSION COMMITTEE ~Dave Rose~

On January 12, 2016, the Pension Board of Trustees met and approved twenty-seven (27) retirements. Six (6) were from the police department.

POLICY REVIEW COMMITTEE ~Dave Rose~

- The committee members did not review any policies this month.
- The Body Worn Camera program is progressing slowly. The Department has received some equipment from the vendor and has begun testing with different types of uniforms and daily police scenarios.
- There are still many issues with implementing the program which include developing a policy, redaction, PIA requests, etc.
- The Governor's Maryland State Body Worn Camera Committee has completed their task of submitting recommendations to the MPCTC for minimum standards.
- Those standards have been received by the committee which intends to use them for guidance.

- As you prepare your tax return this year remember to take the H.E.L.P.S. Act deduction for your pre tax health care premiums.
- The Healthcare Enhancement for Local Public Safety (HELPS) Retirees Act provides a modest tax benefit to retired public safety officers to pay for health care by allowing the use, on a pretax basis, of up to \$3,000 annually from their pension funds to pay for premiums on health care and long term care insurance.

- Federal legislation and resulting Federal legislation and resulting IRS regulations effect individuals differently. Each member is en-couraged to work with their indi-vidual tax professional to deter-mine how the HELPS Retiree Act may apply to them. Additional information can be found on Lodge #4's website.
