FOP Lodge #4 Prevails in Recent Court Decisions

Absence Control Policy

Baltimore County's appeal to the Court of Special Appeals regarding changes to the Absence Control Policy was argued on June 3, 2013. An unreported decision was rendered on June 21, 2013 by Judge Hotten. In the decision, she writes "As a consequence, the Circuit Court properly rejected Baltimore County's argument, when it stated 'if the parties by law or by contract agree to arbitration, you can't opt not to arbitrate, just because [you] don't want to go through the process." She further stated, in part, "In light of the circumstances presented before us, we conclude that the Circuit Court for Baltimore County did not err in issuing a writ of mandamus requiring the County to designate an independent third party agency to receive and investigate FOP's unfair labor practice complaint."

"Thus, if we follow Baltimore County's train of thought, the County contends that because it believes it is under no duty to negotiate, no unfair labor practice was committed, and Mr. Gay was under no duty to designate an independent third party agency to review FOP's complaint. It appears that Baltimore County has placed the proverbial cart before the horse."

"Indeed, contrary to Baltimore County's bold assertions, the Employee Relations Act provides a specific means by which disputes regarding unfair labor practices are to be resolved. Moreover, Baltimore County's proposed interpretation, if adopted, would render the entire dispute resolution system outlined in the Employee Relations Act meaningless. To be sure, well-established canons of statutory construction prohibit statutes from being interpreted in ways that would lead to absurd results, or results that would render meaningless any section of a statute."

Judge Rules the BCoPD Violated the LEOBR

Police Officer First Class Damon White had a hearing on July 8, 2013 in front of Judge Ballou-Watts. Damon White's attorney, Clarke Ahlers, filed a petition to Show Cause under the Law Enforcement Officer Bill of Rights. In his petition, he claimed that the Baltimore County Police Department violated Officer White's rights under the LEOBR, specifically, 3-104(j)(1)(i) - "On request, the law enforcement officer under interrogation has the right to be represented by counsel or another responsible representative of the law enforcement officer's choice, who shall be present and available for consultation at all times during the interrogation." In addition, 3-104(k)(1) states that "a complete record shall be kept of the entire interrogation, including all recess periods, of the law enforcement officer."

After the hearing Judge Ballou-Watts found in favor of Officer White. The FOP will be working with the Legal Section on an agreeable case disposition.



STATE TRUSTEE ~Don Patterson~

On Saturday, June 15, 2013, I attended the Maryland State FOP Board meeting at Anne Arundel County FOP Lodge 70.

- National Trustee Fulginetti discussed three amendments submitted for the National FOP Conference to be held in August, 2013. All three have to do with per capita. The first was submitted by the Kansas State Lodge. It proposes a \$1.00 increase with 50 cents going to the National FOP Officer Relief Fund and 50 cents going to the National FOP Memorial ceremonies. The second was submitted by the Grand Lodge National Board of Trustees. It proposes to add that upon chartering, a new lodge should pay a pro-rated amount of per capita based on the month of charter. The third amendment was also submitted by the Grand Lodge National Board of Trustees. It proposes a \$1.00 increase to the per capita with no designation to where the money should go.
- Secretary Schubert talked about per capita for the second half of 2013. He also advised that any credential changes for the National FOP Conference must be



done by June 30. Rooms for the conference must be reserved by the State Lodge.

The candidates for Attorney General who spoke were Senator Frosh, Delegate Jon Cardin, Delegate Bill Frick, and Anthony Jones, who stood in for Delegate Braveboy.

POLITICAL ACTION COMMITTEE ~Steve Comegna~


- The PAC Committee met on Monday June 24, 2013. We presented four motions to the Executive Board. They are as follows:
