President's Message

On Thursday, July 2, 2020 I met with Chief Hyatt to discuss several items of importance to the membership. The meeting was attended by Chief Hyatt, Lt Steinebrunner and me. The meeting was in the conference room at the Office of the Chief and lasted over three hours.

As the meeting began, I expressed the frustration of the membership throughout the agency that was clearly communicated at the general membership meeting on June 29, 2020. I have never experienced a meeting with that level of anger and dissatisfaction about the agency in all my time with this organization. We had a cross section of all members, ranks, and units within the department. This meeting with her was going to be difficult, but the goal was to be constructive and bring us to a good place and allow us to move forward.

The membership expressed a high level of anxiety about doing this job. They were not speaking about their own personal safety; we all understand this danger is a part of this job. Several members expressed their lack of confidence in the agency supporting them even if they were to take justified action and followed policy/training. The Chief and/or County Administration, if it were politically expedient, would not support them.

Other items discussed include, Police Personnel problems, promotions, the change in IAD process, the Major City Chief's letter, the upcoming session in Annapolis, more visibility with the members, public support of the members, positive BWC videos and examples of de-escalation released to media.

Many members have contacted me to express their desire that the meeting go well, so we can move forward. I believe the meeting went well and was both informative and enlightening. We discussed everything I had on my agenda and topics given to me by members. Chief Hyatt sat and listened attentively, asked good questions, and provided no excuses whatsoever. It is difficult to sit in a meeting and hear feedback on things you thought were going well only to hear things were not so well. However, I believe she will make every effort to evolve and make this agency succeed. In turn, we should be there to help make that happen.

Our membership has expressed their views and displeasure appropriately and professionally. Your FOP leadership has communicated them directly and unfiltered. The lines of communication and inclusion have improved greatly since that meeting. We will continue to work together on the issues facing all of us in the upcoming months.

HEALTH CARE COMMITTEE ~Mike DiCara~

- There was no Healthcare Review Committee meeting this month. Our last meeting with the committee was on May 20, 2020. The focus of the meeting was the pending change to prescription coverage for Medicare eligible retirees. This change, scheduled to take place on January 1, 2021, includes the mandatory use of the Labor First exchange for Medicare supplemental prescription coverage. Labor First is the benefits management company chosen by the County to coordinate an exchange of multiple Rx plan options.
- John Ripley, the Labor chair of the Committee sent a follow-up letter to County Administrative Officer Rogers on May 22, 2020 asking for additional data and clarification of certain points. Chairman Ripley has sent additional requests since that date, but no response has been received.

LEGAL ADVISORY COMMITTEE ~Dave Rose~

- The POFC. Wilkes trial board has been postponed.
- POFC. Taylor's trial board has not been scheduled. President Rose is currently working with the administration on a settlement.

LEGISLATIVE COMMITTEE ~Dave Rose~

- On April 30, 2020 we reached an agreement and signed a letter with the County Administration, changing the length of the probationary period for lateral officers who have completed 2 years of probation in another agency. The County did not agree with our position that the change was a mandatory subject of bargaining. We were in agreement the change was good for all involved. Therefore, our attorney drafted a letter stating that both sides agree to the change and do not forfeit their respective positions as to whether it is a bargaining issue. A bill to change the County Code was submitted in June. It was withdrawn in early July by the administration with no explanation.
- Councilman Julian Jones' "police Reform Bill" will be submitted in July. The draft has many problems. We will look at the final submission when it is submitted.
- There was a virtual meeting on June 23, 2020 with the Police Reform and Accountability work group in Annapolis. The members spoke with the Training Commission about use of force, de-escalation and other training.
- Lodge #4 is working on a strate-

- gy to educate the legislators and the public on what we do and the training we receive. Right now there is a lot of misinformation out there that needs to be addressed.
- Delegate Carl Jackson from the 8th District visited the lodge on June 17, 2020 to speak with President Rose and 1st VP Massey about some educational material the lodge sent out to all 32 Baltimore County Delegates and Senators as well as 139 neighborhood associations and community groups. He was pleased to hear the information we shared and actually reached out to the Chair of the Baltimore County Delegation to request a meeting with FOP Lodge #4.

- President Rose put together a committee to study the lodge officer stipends. They will look at other lodges and see what duties and responsibilities they have and see if we need to adjust our compensation. The committee will consist of Past Presidents, Cole Weston, Tim Caslin and Marc Fiedler.
- President Rose spoke in length about Lodge #4's relationship with the Chief. Numerous members spoke out about how the Chief is handling certain situations as well as the press confer-

- ence she held with the County Executive. President Rose advised he had a webex meeting with the Chief on May 21, 2020 and asked her 9 questions. At the time of our meeting, she had not responded to any.
- President Rose advised he was to meet with the Chief on Thursday after our meeting.
- Officer Marcus Price spoke about being skipped several times for promotion to Corporal. The Chief skipped him and she would not meet with him to give him reasons why. President Rose and Mike Davey met with the Chief to discuss the issue but she still refused to meet with Officer Price.

- During the month of June, FOP Lodge #4 received five (5) thank you cards. Two (2) flower arrangements were sent to bereaving members. Five (5) fruit basket was sent to member recovering from an injury. Two (2) memorial donations were made in lieu of flowers.
