Update on the Retiree Health Care Subsidy Case

The following events have transpired since Judge Finister of the Baltimore County Circuit Court issued a Show Cause Order on April 14, 2014.

- The Court ordered that Baltimore County, Kevin Kamenetz, Keith Dorsey, and Fred Homan shall each appear before the court on June 26, 2014 for a hearing on the Petition for Contempt and show cause why the Court should not hold each in contempt and/or impose sanctions, including incarceration.
- Baltimore County filed a Motion to Quash the Show Cause Order, in part, and to strike the individuals, Kevin Kamenetz, Keith Dorsey, and Fred Homan.
- Baltimore County Fraternal Order of Police Lodge #4 responded to the court with an opposition to the Motion to Quash the Show Cause Order.
- On May 28, 2014 the Court denied the motion filed by Baltimore County.
- On May 30, 2014 Baltimore County filed a Certificate of Compliance with the Court's prior orders. The order certified that the health care subsidy rates for the FOP retirees were reset for each affected retiree to those rates in place at the time of his or her retirement. *This will appear in the June 2014 retirement payment.
- Baltimore County issued a check on May 30, 2014 in the amount of \$1,696,403.98 made payable to the Baltimore County Fraternal Order of Police, Lodge #4. The FOP reviewed the calculations for the payment to ensure they were complete and accurate. The FOP discovered the County missed additional months of subsidy payments, as well as interest that was owed to the retirees. On June 5, 2014 Baltimore County issued a check for \$84,866.00, and on June 10, 2014 Baltimore County issued a check for \$20,209.56.
- *These checks in total, \$1,801,479.54, were deposited in an account established solely for the purpose of secure retention and disbursement to the retirees.

Restoring the rates and issuing the checks for the overcharged subsidy plus interest has satisfied the Circuit Court Order, so the show cause order has been dismissed. Baltimore County filed three appeals to the Maryland Court of Special Appeals concerning the rulings by the Circuit Court. First, on the November 5, 2013 order to restore the subsidy, second, on the March 6, 2014 decision awarding reimbursement to be paid to the over-charged retirees, and third, on the April 17, 2014 decision awarding interest on the money owed to the retirees. All of these appeals have been consolidated into one motion.

The FOP is not able to distribute the reimbursement for over charged health care subsidies until the appeals have been exhausted or withdrawn.

The FOP does not think these appeals have merit and that the November 19, 2012 decision by the Maryland Court of Appeals should have signified an end to this case. We will continue to communicate that to the County Executive and other elected officials in an attempt to stop this waste of tax payer dollars and bring this case to an end.
