President's Statement – Baltimore County Police Department Reforms

As representatives of the Baltimore County Police Department, you and your fellow officers continue to demonstrate professionalism and dedication to service throughout the county. Over the last three months, you have provided support and assistance beyond the typical call of duty, ensuring the health and safety of our communities during a global pandemic and a period of tragic loss in communities of color. As law enforcement officers, we have a trusted responsibility to protect and serve. The conduct of the officers involved in the George Floyd incident in Minneapolis is inexcusable. Their behavior and use of force have no place in our profession. Because of their actions, there is a stain on our profession. As a citizen and as a police officer, I am saddened by the death of George Floyd, and share in expressing my heartfelt condolences to his family, friends, and community.

We hear the calls from politicians and protesters for reform and change in policing across the country, and, as the leadership of Baltimore County Fraternal Order of Police Lodge #4, we stand ready to assist and engage in those conversations. We are not opposed to change. Change in policing is constant. It is one of the things that makes this profession so great. Any truly meaningful change cannot take place without collective involvement for all parties. Politicians, community leaders, and members of the rank and file law enforcement officers need to work together to modify and develop policy that is clear and concise. Officers must have a clear understanding of those policies for them to be effective. And law makers must have a clear understanding of our county and state law enforcement programs and the internal rules and regulations our officers our governed by.

An example of this collaboration can be seen in the 2017 publication of the <u>National Consensus Policy on Use of Force</u>. This publication reflects 11 of the most significant law enforcement leadership and labor organizations in the United States and contains the best thinking of all consensus organizations and may serve as a template for upcoming conversations between law enforcement agencies and those seeking improvements in policing.

For several years, our members have been trained using national best practices in use of force. Those trainings include de-escalation training, Integrating Communications, Assessment and Tactics (ICAT), and implicit bias training, the concept of Sanctity of Life, the Duty to Intervene and Report excessive or unnecessary use of force, and the importance of Constitutional Policing. Our agency has been ahead of the curve in all those areas, as evident in our statistics in use of force and arrests. These numbers have continued to decline for over a decade.

As law enforcement professionals, we know you will continue to work hard for the residents of Baltimore County and build meaningful relationships within the communities you serve and who have instilled their trust in you. Please know your FOP Lodge #4 leadership remains committed to our representation of you and your colleagues. DONATION REVIEW **COMMITTEE** ~Ryan Franks~

There was no requests for donations this month, however we received a thank you from County Executive Olszewski for our donation to the COVID-19 Emergency Response Fund and a thank you from Kylee's Dancing Angels Foundation.

HEALTH CARE REVIEW **COMMITTEE** ~Mike DiCara~

- On May 5 and May 20, 2020, webex meetings of the Health Care Review Committee were conducted by CAO Rogers. The focus of the meetings was the pending change to prescription coverage for Medicare eligible retirees. This change, scheduled to take place on January 1, 2021 includes the mandatory use of Labor First for supplemental prescription coverage. Labor First is the benefits management company chosen by the County to coordinate an exchange of multiple plan options. Representatives from Labor First presented possible choice options for their exchange, and discussed the process by which these plans were chosen. Minor changes to health coverage for active employees and pre-65 retirees were also discussed. Our consultant, Randy Hart, requested that the County provide additional documentation to support the fee structure presented by Labor First.
- John Ripley, the Labor chair of the HCRC, also sent a follow-up • letter to COA Rogers asking for additional data and clarification of certain points. More updates will be provided in the near future.

LEGAL ADVISORY **COMMITTEE** ~Ryan Massey~

- POFC. Taylor hearing board has not been scheduled. President Rose is attempting to reach a settlement.
- The POFC. Wilkes hearing board scheduled for June 8, 2020 has been postponed.

LEGISLATIVE COMMITTEE ~Dave Rose~

On April 30, 2020 we reached an agreement and signed a letter with the County Administration, changing the length of a probationary period for lateral police officers who have completed 2 years of probation in another agency. The County did not agree with our position that the change was a mandatory subject of bargaining. We were in agreement that the change was good for all involved. Therefore, our attorney drafted a letter stating that both parties agree to the change and do not forfeit their respective positions as to whether it is a bargaining issue. A bill to change the county code will be submitted in June.

NEGOTIATION COMMITTEE ~Dave Rose~

The County Council delayed budget deliberations until May 28, 2020 in hopes of another federal stimulus package being passed by Congress. The hope was that if there was another stimulus package, the council could avoid drastic cuts from the budget. The FOP reached out to the Administration and was able to renegotiate our previously ratified agreement. We were able to

keep everything we bargained for in the original agreement except the wage increase, which was delayed 6 months later in the contract year. When the County Council voted on the budget on May 28, 2020, our agreement remained intact.

PENSION COMMITTEE ~Dave Rose~

• At the May 12, 2020 Pension Board of Trustees meeting, the trustees approved fourteen (14) total retirements, three (3) from the Police Department.

POLICY REVIEW COMMITTEE ~Dave Rose~

• The committee reviewed eight (8) new or revised policies and identified no bargaining issues with any of them.
