- Motions that were made, after receiving a proper second, were discussed, voted upon, and appear in this issue under the appropriate committee reports.

• The 2019 FOP Lodge #4 Bull Roast was held on Sunday, March 24, 2019. Report will be in next month's newsletter.

#### DONATION REVIEW COMMITTEE ~Mike DiCara~

- The Donation Review Committee met and brought forth the following motions which passed.
- To donate \$300.00 to St. Baldrick's Annual Fundraiser to cure childhood cancer.
- To purchase a table of ten for the Police Emerald Society's Blue Line Bash for a total of \$600.00.
- To donate \$300.00 for a Bronze sponsorship for Kylee's Angels bull roast to raise money for sarcoma research.
- To donate \$250.00 to the Casey Cares Foundation's annual gala to raise money for critically ill children.
- These motions were passed by the Executive Board of Directors and there was no opposition from the general membership.

#### GRIEVANCE COMMITTEE ~Dave Rose~

•

- On February 25, 2019, the committee met to discuss a directive from Colonel Folderauer to 1st VP Comegna and 2nd VP Rose stating "You were marked working Shift 2 on Martin Luther King Day. This should not have occurred. You are directed not to report to work on President's Day, Monday, February 18, 2019. Both of you will be marked "P". Both of you will be marked "P" for two other holidays (Columbus and Veteran's) this year per Section 6.11."
- The Memorandum of Understanding between the County Administration and the Fraternal Order of Police Lodge #4 states specifically under Article 12, Section 12.6: FOP President: During the term of this Memorandum of Understanding, the President of the Baltimore County Lodge #4, Fraternal Order of Police, Inc. shall designate two (2) appointees of the bargaining unit who shall be granted a full time leave of absence from their duties for the Police Department, mandated in-service training excepted, but shall remain on the payroll of the Police Department for the purpose of performing full-time duties on behalf of the FOP. During such leave, the appointees shall continue to accumulate seniority and shall receive all benefits as if said employee were fully on duty, including, but not limited to, pension accruals and fringe benefits.
- Sgt. Comegna and Sgt. Rose were appointed by the President. Both Sgt. Comegna and Sgt. Rose had to work on President's Day to conduct their duties for the FOP and should be compensated accordingly.
- A motion was made to file a

grievance and there was a proper second. The motion passed. The motion was presented to the general membership and there was no objection.

- The committee discussed a grievance by POFC. Fuller from Precinct #9. She was contacted at home by her sergeant on her day off at the direction of her Captain to perform work in reference to a threat on a student. She did as she was directed and submitted a compensatory leave form seeking compensation under Section 6.4 and 6.5 of the MOU. She was denied by her Commander and was offered compensation "hour for hour". Attempts to resolve the grievance with the immediate supervisor was unsuccessful. The committee reviewed the language in the MOU and past grievances for precedent. A motion was made to file a grievance under 6.4 and 6.5 of the MOU by Mike DiCara and a proper second was made by Kathy Kraemer. The motion passed unanimously. The grievance was delivered to Captain Conger on February 8, 2019.
- The grievance hearing was held at Precinct #9 on February 15, 2019. The facts of the case were explained in detail as well as the presentation of past grievances to support our position. If both sides are in agreement that the time spent "performing work" is compensable, then under the provisions of the MOU it is "call back and day back". There is no provision for hour for hour compensation. On February 22, 2019, Captain Conger issued a written decision granting the grievance.
- The County has filed an appeal to the Court of Special Appeals in the Section 6.1c grievance. The County filed their initial

brief. Our brief was filed on January 9, 2019. The County did not respond. No hearing date has been scheduled.

- The FOP and the County had the health care arbitration hearing on January 15, 2019. Second VP Rose and First VP Comegna attended and both testified for our position. County Budget Director
  Keith Dorsey and County Consultant Mark Lynne testified for the County. The initial brief for the FOP was filed on February 22, 2019. The County has 30 days to file their brief. The FOP will then have 10 days to respond. The arbitrator has another 30 days to give her decision.
- The step #3 grievance for the specialized assignment process was heard on August 10, 2018 at the Office of Administrative Hearings by Judge Stahl. He issued his decision on August 23, 2018 and denied the grievance. We submitted our notice of intent to arbitrate on September 19, 2018. Arbitrator Marvin Johnson has been selected to hear the grievance. No hearing date has been set.
- We presented the POFC. McCain reschedule pay grievance on November 1, 2018 at step #3, the Office of Administrative Hearings. Judge Stahl issued a decision on November 14, 2018 denying the grievance. We submitted our notice of intent to arbitrate on December 5, 2018. The Legal Advisory Committee met on December 17, 2018 and voted to appeal to arbitration. The Executive Board of Directors also approved the appeal. There was no opposition from the general membership.

#### LEGAL ADVISORY COMMITTEE ~Dave Rose~

- On February 25, 2019, the committee met to discuss filing an unfair labor practice against the Baltimore County Administration.
- On or about February 7, 2019, the Baltimore County Police Department conducted the promotional draft without including representation from the Fraternal Order of Police Lodge #4 (FOP) in the promotional draft process. The parties have a continuous practice dating back decades whereby FOP representatives have been invited and have participated in the promotional draft. Indeed, consistent with that established practice, the Department scheduled a meeting on February 7, 2019 with FOP representatives to conduct the promotional draft. The Department subsequently cancelled the February 7, 2019 meeting and conducted the promotional draft without involvement of the FOP's representatives. The Department sent out the results of the promotional draft process on February 7, 2019.
- The decision of Baltimore County to conduct the promotional draft without the involvement of the FOP's representatives constitutes a unilateral change in the terms and conditions of employment and a refusal to bargain in good faith violation of Sections 4 -5-310 and 4-5-201(a) of the Baltimore Count Code and an unfair labor practice under Sections 4-5-203(a)(1) and (4) of the Baltimore County Code.
- A motion was made to file the complaint. There was a proper second. The motion passed. It was presented to the Executive Board of Directors and passed.

There was no objection from the general membership.

- Chairman Rose assisted POFC. Bordner's attorney, Clarke Ahlers in reaching an agreement for her resignation, which was effective February 12, 2019.
- On February 8, 2019, the committee received a request from POFC. Bordner for reimbursement of \$13,250.00 in attorney fees. In March 2017, the committee and the Executive Board of Directors denied her request for legal fees for an attorney for representation already covered by the lodge retainer with SBW Law. As per the bylaws, she is seeking a partial reimbursement now that her case has concluded.
- The committee members discussed this request at great length. Ultimately, a motion was made to reimburse \$1,000.00.
   There was a proper second and the motion passed unanimously.
   The committee recommendation was presented to the Executive Board of Directors and the board concurred.
- The attorneys for Ericka Barnes have filed a complaint for a Writ of Mandamus on her behalf. Generally, a writ of mandamus is an order from a court to an inferior government official ordering the government official to properly fulfill their official duties or correct an abuse of discretion. No hearing date has been set. The case was scheduled for mediation with retired Judge Platt on February 27, 2019. A hearing for the Mandamus is scheduled for July 9, 2019 with Judge King. The appeal has been stayed pending the outcome of the Mandamus hearing.
- A writ of mandamus was filed in Baltimore County Circuit Court on August 20, 2018 for the Marvin Haw case. No date has been set. However, the County

Administration submitted Bill 77-18 to County Council on October 1, 2018. The bill, which was passed by Council, permitted a "beneficiary" to appeal a decision of the Board of Trustees to the County Office of Administrative Hearings and the County Board of Appeals. This was in effect retroactive to March 14, 2013. The case has been remanded back to the OAH. No date has been set.

#### PENSION COMMITTEE ~Dave Rose~

• At the February 12, 2019 Pension Board of Trustees meeting, the trustees approved thirteen (13) total retirements, eight (8) were from the Police Department.

#### POLICY REVIEW COMMITTEE ~Dave Rose~

• The committee members reviewed fourteen (14) new/ revised policies this month. No bargaining issues were identified.

#### POLITICAL ACTION COMMITTEE ~Steve Comegna~

- The Political Action Committee met on Monday, February 18, 2019. There were two motions presented to the Executive Board of Directors. They were as follows:
- To transfer \$6,000.00 from the General Fund Account to the Political Action Fund.
- To purchase a \$500.00 sponsor-

ship to an event for Baltimore County Councilman David Marks (District #5) on Thursday, March 21, 2019.

These motions were approved by the Executive Board of Directors on Monday, February 18, 2019. This report was presented to and approved by the general membership on Monday, February 25, 2019 at the General Membership meeting.

#### GOOD OF THE ORDER

During the month of February, FOP Lodge #4 received four (4) thank you cards. Five (5) flower arrangements were sent to bereaving members. Three (3) fruit baskets were sent to grieving members. One (1) memorial donation was made in lieu of flowers.



## **Membership Passes to the National Aquarium**
