

Baltimore County FOP Lodge 4 Mourns the Loss of POFC Amy Caprio End of Watch 5/21/2018

Officer Caprio was killed on May 21, 2018 while she was investigating a call for a suspicious vehicle. She was a professional, dedicated officer who will be missed by her family, co-workers and the entire community that she served. She had a full honors funeral ceremony at Dulaney Valley Memorial Gardens. She is the tenth Baltimore County Officer killed in the line of duty in the 144 year history of the Department.

 - At the April 14, 2018 Maryland State FOP meeting, Governor Hogan spoke about his support of Law Enforcement and thanked us for our support of him. He presented a citation to President Canales recognizing the 50th Anniversary of the Maryland State FOP. He also presented 2 citations to Brother Ryland and Treasurer Kratsch recognizing them as members who have been here all 50 years.

DONATION REVIEW COMMITTEE ~Mike DiCara~

- The Donation Review Committee met and discussed the following motions:
- To donate \$2,500.00 to Dulaney Valley Memorial Gardens to support Fallen Heroes Day, May 4, 2018.
- To donate \$250.00 to purchase advisor polo shirts for the 2018 National Explorer Conference to be held in July 2018.
- To donate \$1,500.00 to Special Olympics Maryland in support of the 2018 Torch Run.
- To purchase a table 10 tickets to the Anne Arundel County Lodge #70 Bull Roast on May 19, 2018 for an expenditure of \$400.00.
- To donate \$500.00 as a bronze sponsor for the 19th Annual COPS Ride on Sunday, June 10, 2018 to benefit the Maryland Chapter of Concerns of Police Survivors.
- To donate \$250.00 to the 2018 Congenital Heart Walk to support infants born with severe heart defects. Sponsorship is for Brother Mike Deremeik (PC9) whose son was born with this condition and under went heart

surgery at 10 months old.
 All motions received proper seconds and were passed.

GRIEVANCE COMMITTEE ~Dave Rose~

- The motion to enforce in Baltimore County Circuit Court in the Section 6.1c grievance was scheduled for May 2, 2018 in Judge Souder's court room.
- The FOP and the County have agreed on an arbitrator in the health care subsidy grievance.
 There is no scheduled hearing date.
- On April 16, 2018 the Grievance Committee met to discuss two separate Class Action Grievances
- On February 27, 2018 the Department published Employment Section Personnel Announcement #07-18. This was a Notice of Specialized Assignment Selection Process in the Youth & Community Services Section of the Operations Bureau for an Animal Abuse Investigations Team Supervisor, specifically for the rank of Sergeant. The application deadline was March 13, 2018. Shortly thereafter, the Department selected a Sergeant to fill this position.
- On or about the beginning of April, the Department reassigned the Animal Abuse Investigations Team to the Criminal Investigations Bureau, specifically the Property Crimes Section. Even though there exists a current eligibility list for the position of Sergeant in CIB, the Department did not fill the Sergeant position with a Sergeant on that eligibility list.
- The FOP became aware of this and contacted the Bureau Commander, Colonel Hlavach on

- April 10, 2018. Colonel Hlavach confirmed that the above summary was accurate, including confirming that the Sergeant selected for the Animal Abuse Investigations Team was not on the current eligibility list and did not participate in the application process for CIB. Colonel Hlavach further informed the FOP that the Department would not select a Sergeant from the current eligibility list to fill the CIB Sergeant position.
- The position of Sergeant for the Animal Abuse Investigations Team is in the Criminal Investigations Division, Property Crimes Section. The Department has an established, longstanding practice to fill such vacancies. In this regard, the Department established an eligibility list pursuant to Article 7-10.3 of the Administrative Manual. According to the practice, the position of Sergeant for the Animal Abuse Investigations Team in CIB must be filled from those on the current eligibility list.
- A motion was made by the Grievance Committee to file a class action grievance in selection process for CIB.
- On March 15, 2018, Lt. Peach, Commander of the K9 Unit sent out a directive to the K9 handlers in reference to compensation for transporting their K9 dogs to and from approved kennels. The directive stated in part "From this point forward K9 handlers will not be provided extra compensation in the form of compensatory leave or overtime in order to transport their K9 partners to the kennel for any actions they take in placing their dog in the kennel. Additionally, K9 handlers will no longer be marked working for any amount of time in order to transport their assigned K9 dog to or from the

- kennel or for any actions they take in placing their dog in the kennel.'
- This directive unilaterally changes longstanding Department practice in which the Department, for a significant period of time, has treated as compensable, the time K9 officers took to transport the K9 dog to and from the kennels. In this regard, Department policy • requires K9 officers to house K9 dogs at the kennel when certain circumstances arise.
- On March 27, 2018, Second VP Rose met with Captain George, Section Commander of the Special Operations Division, who oversees the K9 Unit to discuss this directive by Lt. Peach. Captain George acknowledged during the meeting that he was aware that K9 officers had, for a significant period of time, been compensated for transporting the K9 dog to and from the kennel but that the practice was being discontinued. It was the position of the FOP that transporting the dog to and from the kennel was compensable time. At the conclusion of the meeting, Captain George stated he would take the FOP's position back to his office and discuss it with his chain of command.
- On April 4, 2018, Captain George contacted Second VP Rose and informed him that his position communicated in the directive would remain unchanged.
- A motion was made to file a class action grievance dealing with K9 and compensation pay.

LEGAL ADVISORY **COMMITTEE** ~Dave Rose~

The show cause petition in Baltimore County Circuit Court for

- the Bordner case has not been scheduled. Both sides have submitted their motions in preparation for the hearing.
- The show cause petition filed in **Baltimore County Circuit Court** in the Estes case has not been scheduled. Both sides have submitted their motions in preparation for the hearing.
- Mike Marshall and his staff are working on the Marvin Haw pension appeal to the Board of Appeals. Mr. Marshall did send a letter on February 8, 2018 to the Board of Appeals requesting they set a date. No date has been set.
- The Ericka Barnes appeal of her spousal pension benefits was presented at the County Board of Appeals on February 14, 2018. A written decision dated March 1, 2018 was distributed to all parties on March 5, 2018. As expected, the Board members stated there was no appeal issue to their level and ruled that all administrative remedies have been exhausted. On March 29, 2018, attorneys for Ericka Barnes filed a Petition for Judicial Review in the Baltimore County Circuit Court.

MEMORIAL COMMITTEE ~Don Patterson~

Baltimore County Police Memorial was held on Friday, May 11, 2018. After the service a reception was held at Lodge #4. A motion was made to pay for the cost of food for 50 people. The cost was \$1,385.00. The motion was second and passed.

PENSION COMMITTEE ~Dave Rose~

At the April 10, 2018 Pension Board of Trustees meeting, the trustees approved twenty-three

- (23) total retirements, two (2) were from the Police Depart-
- The Board voted to recommend to County Council that the calculation for a retiree COLA be modified for the current calculation based on a 10 year smoothing to an 8 year calculation. This recommendation has to be approved by County Council.

POLICY REVIEW COMMITTEE ~Dave Rose~

- The committee members reviewed six (6) policies this month.
- On February 2, 2018, Chief Sheridan sent an email agency wide regarding secondary employment approval and the submission of schedules. We are currently in communication with the Planning Unit to revisit the scheduling section which has not been updated for 20 years. Currently there is a draft out for Command Review. The Policy Review Committee will have it after that process is completed.
- Currently, the Committee is reviewing the new Medical Marijuana Policy. We have communi-Je Un some aspects

- Chief's Office. Upon review of that response, we filed a request to bargain on April 12, 2018.
- We have not been asked to participate in any of these policy discussions.
- There is also a K9 compensation question regarding a new policy from the Commander on March 15, 2018 that states K9 handlers will no longer be compensated for travel to and from the kennel (mileage or time) when kenneling the dogs. After meeting with the Commander on March 27, 2018 and communicating our concerns he communicated them to his chain of command. He contacted the FOP on April 4, 2018 and stated the position of the Department has not changed and the directive will remain in
- The policy change is being addressed as part of the grievance that was filed.

POLITICAL ACTION COMMITTEE ~Steve Comegna~

- The Political Action Committee met several times in the past month. We met on Monday, April 16, 2018, Tuesday, April 17, 2018 and Thursday, April 19, 2018.
- The committee brought forth four recommendations at two different meetings. Those motions was as follows:
- To endorse State Delegate Joe Cluster (District #8) in his reelection campaign.
- To endorse Baltimore County Councilman Tom Quirk (District #1) Julian Jones, Jr.

- (District #4), David Marks (District #5) and Todd Crandell (District #7) in their 2018 reelection campaigns.
- To endorse Baltimore County Councilwoman Vicki Almond in her campaign to become Baltimore County Executive.
- To purchase a \$1,000.00 sponsorship to an event for Vicki Almond on Wednesday, May 23, 2018.
- The Executive Board of Directors thoroughly discussed each motion and then voted unanimously to support each motion. These motions were then presented to the General Membership at the April 2018 meeting. After a proper second, a presentation was given on each motion. The membership of FOP Lodge #4 unanimously approved each of the motions.

NEW BUSINESS

- Past President Caslin made a motion to support Brother Schubert in his run for State Secretary and Brother Tony DiCara in his run for State Chaplain. Motion received a proper second and passed unanimously.
- First VP Comegna made a motion to spend up to \$2,000.00 to paint and buy new blinds for the upstairs of the Lodge. Motion was passed.
