HEALTHCARE REVIEW COMMITTEE ~Mike DiCara~

- A meeting of the HCRC and the County Administration was held on August 23rd.
- At this meeting, the County agreed to the Committee's proposal for an annual county contribution to HSA accounts for members who choose the Cigna high deductible plan. This contribution

- will be \$500 for individual plans and \$1000 for family plans. Money in these accounts roll over from year to year, is portable when a member leaves county employment, and can be used for any qualifying medical expense.

- The County also agreed to no structural changes in next year's plans, meaning no increases in any co-pays, and no reductions in coverage for 2022.
- Based on our consultant's review of county claims data and rate projections, the committee believes that there will be little change to next year's premium amounts. The final rates will be issued by the County at a follow-up meeting scheduled for October 5th.

We have submitted our DROP proposal to the County Administration before the October 1 deadline. They will have their Actuary review the document.
 Once that review is complete, we will meet and discuss the proposal.

PENSION COMMITTEE ~Don Patterson~

• At the September 14, 2021 Pension Board of Trustees meeting, the Board approved 39 total retirements, 3 from the Police Department.

POLICY REVIEW COMMITTEE ~Dave Rose~

- On August 23, 2021, the Baltimore County Public Schools Administration (BCPS) announced a vaccination and testing program. I made inquiries with the Chief's Office and County Administration as to the effects of this policy on our members who work in the school system. After some limited response, on August 26, 2021, I drafted and sent a demand to bargain letter over the BCPS policy and any future County Administration policy.
- On September 9, 2021, the County Administration announced a policy requiring employees to show proof of vaccination by November 15, 2021, or submit to weekly testing. We met with the Deputy Administrative Officer (DAO) shortly after the Executive's announcement. We stressed the many areas of disagreement and unresolved procedural issues along with our opposition to any vaccination and testing policy.
- On September 23, 2021, I spoke with the DAO and communicated it was evident there will be no resolution in our negotiations prior to October 1, 2021. They agreed and decided to delay any implementation of the policy until November 1, 2021, or until we can resolve the many issues that remain.
- At this time, we have not received answers to the many questions we presented. We

- drafted and submitted a proposal to the DAO and are waiting for a response. We will continue to work on this issue and bring information to the membership as it becomes available. We are trying to schedule another meeting as soon as possible.
- We will continue to communicate it is the position of the FOP that an employee should have the right to choose whether or not to be vaccinated. We will provide more information as it becomes available.
- On August 27, 2021, we met with Planning and Research, Legal and Executive Corps representatives to discuss the upcoming legislation going into effect on October 1, 2021, and July 1, 2022.

POLITICAL ACTION COMMITTEE ~Mike DiCara~

- The Political Action Committee met on Monday, September 20th. There were three motions brought forth to the Executive Board of Directors for approval.
- To purchase a \$500 Silver Sponsorship for a fundraiser for State Senator Bob Cassilly on Saturday, November 6th.
- To donate \$500 to State Senator Michael Hough.
- To purchase a \$125 Couples ticket for a fundraiser

NEW BUSINESS

- On Monday, September 27, 2021, several motions were made and passed at the general membership meeting. These motions were as follows:
- Baltimore County FOP Lodge #4 is opposed to any vaccine mandate.
- Baltimore County FOP Lodge #4 is opposed to any mandatory COVID testing.
- Baltimore County FOP Lodge #4 is opposed to any COVID test that uses any known carcinogens.
- It is the position of Baltimore County FOP Lodge #4 that if testing is mandated, all employees be tested and the Administration report to the union information related to the number of employees vaccinated/tested/quarantining/etc.

- It is the position of Baltimore County FOP Lodge #4 that if any member of Baltimore County Government is exempted from COVID testing for any reasons other than ADA or religious accommodations, all members of Baltimore County Lodge #4 will be exempted from testing.
- The maker of the motion clarified that these motions were only to communicate the position of the membership and was not meant to constrain of obstruct the ability of the lodge to negotiate in good faith with the County Administration over a policy.

GOOD OF THE ORDER

- During the month of August, FOP Lodge #4 received six (6) thank you cards. Two (2) memorial donations were made in lieu of flowers. Three (3) flower arrangements were sent to grieving members.
- Legal Advisor Mike Davey reminded the members that new laws go into effect on October 1, 2021. One of those will make your personnel files open to any one who would like to see them. He advised you get anything that you can expunged.
- Mike Davey also talked about the new policy of the Attorney General's Office investigating deaths where the police were involved.
- Doug Dunlap spoke in support of Senator Chris West.
