# PRESIDENT'S MESSAGE

It has been an honor to serve as President for the last two years. Looking back, I am reminded of the many challenges we faced together and the successes we have made. Some of the challenges we faced are unprecedented, the two biggest being COVID-19 and the attacks on local and statewide law enforcement.

Despite these challenges, our members continue to rise to the occasion when called upon to ensure our voices are heard. Through collective efforts to lobby county council, senators, and delegates in Annapolis, we were able to keep key provisions from the LEOBR and defeat the radical "Police Reform" legislation drafted by Councilman Jones and have a substantial impact on the statewide bills.

We passed additional local legislation which prevented most Executive Corps members (excluding Colonels) from having to submit unnecessary financial disclosures as well as lowering the period of probation for lateral officers from two years to one year.

Our success continued in the negotiations with the County Administration by working to enhance and secure the salary and benefits for the membership. In addition to pay increases, we eliminated the minimum step to make the move from probationary police officer to police officer first class a two step pay increase. This enables all members to reach maximum step one year earlier. Members with military service can now receive credit for their service without having to forgo their military pension. We also worked closely with the administration to change the qualification for the Joint and Survivor Benefit (a.k.a Widows Benefit) to twenty-five years of pension credit instead of the twenty-five years of service as a Baltimore County Police Officer, making the qualification the same as every other benefit. Most importantly, we secured a two-year contract which will push back some of the changes in the 2021 Annapolis Session an additional year.

These negotiations were not easy at times. After our first contract negotiations in March 2020, COVID-19 was on the rise and the government shut down not only threatened the economy but also the funding for our contract. We worked with the administration and members of county council to not only keep every provision in the agreement, but also to obtain hazard pay and administrative leave for those affected by COVID.

We also reinvested in our organization's communication and file systems, security, and public presentation. We upgraded our file system to a cloud server and equipped the lodge with virtual conference capabilities and high-speed internet on both floors, giving our members the tools to perform their jobs efficiently and adapting to the new communication avenues that evolved throughout the last eighteen months. The front entrance of the lodge was also replaced to provide additional security and safety measures. We were also able to replace dilapidated office furniture and vehicles to ensure our organization keeps a professional appearance both to members and the public. We accomplished this while increasing the net worth of the organization by over \$700, 000 in 2020.

As a lodge, we continue to work to enhance our communication to the membership and our community presence. As of this writing, we have been to eighty (80) roll calls county-wide. We continue to improve our communication with the membership, not only in person, but through telephone, text, email, various social media platforms, as well as our FOP app.

We created an email database of 150 community groups which has been a tremendous success, allowing us to participate in community forums both in person and virtually. Our Community Conversation and Reference Guide, outlining our professionalism, education and training was another success.

Our "Breaking Point" article, which focused on personnel shortages and the lack of facilities and equipment has shed light on an issue of great need in the department, and garnered both mainstream and social media attention. We received coverage from Channel 2, Fox 45, WBAL and local newspapers. In the last 2 months we have spoken at political functions, community associations, Police Community Relations Council and any other group that will give us an audience to speak. We also sponsored events with Kona Ice as well as basketball, baseball, and biking events in the community. This type of outreach and communication is essential if we want to get funding we deserve and need to become an agency that attracts qualified candidates.

Moving forward we will continue to support the membership on the current issues by which we are confronted. We will always attempt to resolve them amicably and professionally. However, if necessary, we will not hesitate to utilize the various dispute resolution processes available to us.

## GRIEVANCE COMMITTEE ~Ryan Massey~

On 8-26-21 a Class Action Grievance (Alan Hamby) in reference to Military Time for membership in the Maryland National Guard. President Rose argued on behalf of FOP 4 and Jim Ruckle on behalf of the County. The hearing was presided by Hearing Officer Murphy. President Rose argued that the County code was clear in it stating membership in the Maryland National Guard, would entitle an employee to pension credit and it • doesn't mention "active-duty time" like it describes elsewhere in the provision. Jim Ruckle argued that it does state that in the County Code but he submitted, as an exhibit, notes from a 1977 Pension Board of Trustees meeting, that the board decided that they would only consider "active • -duty time" for pension credit as the reason why the grievance was being denied. He further added if an employee wanted the policy changed, they should seek such a remedy from the Pension Board of Trustees or through the

County Council making the County Code. It was the Hearing Officer's understanding that the notes from the 1977 Pension Board meeting were just that, notes and they were never added to the Baltimore County Code.

• On 8-30-21 the Hearing Officer ruled that this matter should be taken up with the Pension Board Trustees for a ruling.

#### HEALTHCARE REVIEW COMMITTEE ~Mike DiCara~

- A meeting of the HCRC and the County Administration was held on July 12<sup>th</sup> and was reported on at the July meeting.
- A follow-up meeting with the County is scheduled for August 23<sup>rd</sup>. We anticipate the county's response to the committee's 2022 proposal at this meeting.

#### LEGAL ADVISORY COMMITTEE ~Ryan Massey~

- POFC K. Mallette Trial Board is scheduled for September 21-22, 2021.
- POFC W. Johnson Trial Boards have been postponed and not rescheduled.
- POFC W. Johnson has a Trial Board scheduled for October 13-14, 2021.

- POFC Vicosa Trial Board took place on August 4<sup>th</sup>. PFC Vicosa was charged with sleeping while
  on duty, insubordination & conduct unbecoming of an Officer. He pleaded not guilty to all charges. After numerous witnesses testified for the Depart-

ment, the board found PFC Vicosa guilty of all charges (unanimously). The punishment for each charge was 2 days loss of leave, termination, and termination respectively (unanimously).

### NEGOTIATION COMMITTEE ~Dave Rose~

- We have submitted the necessary documents requested by our actuary to begin the process of developing DROP proposals to discuss with the administration.
- The signature page on the new Memorandum of Understanding is complete. Once the printing is complete we will distribute them to the membership.

# PENSION COMMITTEE ~Don Patterson~

- There have been questions about retirement system COLAs. Baltimore County Code Section Section 3-3-902 requires 11 members of the Pension System Board of Trustees (BOT). The County Code gives the County Executive direct control of six (6) of the eleven (11) positions. The County Council appoints two (2) positions. We currently have three (3) votes; the two active members and one retired member.
- To change the current ten (10) years smoothing and eight year geometric average calculation for a COLA would require a majority vote of the trustees.
- We are asking all retirees to email and or call the County Executive and members of County Council and tell them the system calculation for retiree COLAs should return to the pre 2009 calculation.

- 3-3-902. MEMBERSHIP
- (a) Composition; appointment of members.
- (1) The Employees Retirement System Board of Trustees consists of eleven trustees.
- (2) Of the eleven trustees:
- (i) The County Council shall appoint two trustees and the County Executive shall appoint one trustee, each of whom must be a resident of the county who:
- 1. Does not hold an elective or appointed office or other employment with the county or state;
- 2. Is not a member, retired member, or beneficiary of the Retirement System or any retirement system provided for under any provision of state law or any county or municipal retirement system;
- 3. Is not an employee or member of a public or private sector employee union; and
- 4. Is knowledgeable and experienced in the administration and operation of pension systems, investments, or trust funds.
- (ii) The following five trustees shall serve ex officio:
- 1. The County Executive or the County Executive's designee;
- 2. The Director of Budget and Finance;
- 3. The Director of Human Resources;
- 4. The Director of Public Works; and
- 5. The Chief of the Police Department;
- (iii) Two trustees shall be members of the retirement system

elected by the members of the retirement system; and

• (iv) One trustee shall be a retired member of the retirement system elected by the retired members of the retirement system.

# August 2021 Trustee Report

The 2021 National Fraternal Order of Police Biennial Conference was held August 15-19 in Indianapolis, Indiana. Lodge #4 was represented by 35 Delegates including State Secretary Ken Schubert.

The Credentials Committee reported on Thursday, August 19, 2021, that there were 3462 Registered Delegates and 273 Registered Alternates for a total of 3735 attendees.

Monday was fairly uneventful with only local leaders and Chiefs speaking and some committee reports. After close of business on Monday, the Maryland delegation met to discuss the 24 Amendments that would be discussed and voted on Tuesday. There was lengthy discussion about Maryland staying together as one since we had an issue in New Orleans. Amendments 1through 11 were discussed and Maryland agreed with the Conference Committee to adopt as written. Amendment 12, 13 and 14, Maryland voted to reject. Amendment 15 and 16, Maryland voted to adopt. Amendments 17-23 were for pay increases for the National Officers. There was much discussion and even though the delegation felt they deserved pay increases, the percentages were high. The Presidents, Secretary and Treasurer would be increased about 45%. The Vice President, 2<sup>nd</sup> Vice President, Sgt-at-Arms and Chairman of the Trustees would increase about 204%.In the end, Maryland voted in the caucus to reject the pay raise amendments as written. Amendment 24 was rejected by the Conference Committee and Maryland agreed to reject. We also elected Lisa Riha from Lodge #3 as Maryland's National Trustee.

Tuesday came along and it became more exciting. The Governor of Indiana spoke as did Senator Todd Young. Both expressed their commitment to Law Enforcement or as they said, Indiana "Backs the Blue". Then came the nomination for National Officers. All officers ran unopposed. The nominations were Pat Yoes for President, Joe Gamaldi for Vice President, Jimmy Holderfield for Secretary, James Smallwood for Treasurer, Steve Weiler for 2<sup>nd</sup> Vice President and Keith Turney for Sgt-at-Arms. Rob Pride was selected by the States National Trustees as the Chairman of the Trustees.

Nominations were opened for 2025 Conference Site. There was a presentation from Miami Fop to hold the Conference there in 2025. After their presentation they had a special guest to speak to the delegation. The guest was Governor Ron DeSantis. He spoke about how Florida is also a "Back the Blue" state. He also did some recruiting by telling of bonuses being given to certified officers from out of state. He was very well received by the delegation, many of whom hope that when he follows through with his commitment to be present at the 2025 Conference, it will be as President of the United States.

Now for Wednesday, the day stated with the 24 Amendments that were submitted and we discussed on Monday. Amendments 1-11 passed. Amendment 12 and 13 failed. Amendments 14,15 ,and 16 passed. Then there was discussion on the floor in reference to Amendments 17-23. A motion was made to take all 7 amendments as 1. The motion passed. A vote was called for all 7 and it was a close voice vote. A two thirds majority is needed to pass a bylaw change, so a division of the house was called. This means those for will stand when called and those against will stand when called. Maryland, who voted to reject these amendments in our caucus would stand when the no vote was called. All of Maryland's delegation stood at this time. Baltimore City Lodge #3 stood when the vote for the amendment was called and there was much heated discussion. Prince Georges FOP 89 people were extremely upset with the city. Also the Executive Board was taking heat for not stopping it, however the decision was made by Lodge #3 without telling the Maryland State President.

Amendment 24 was rejected. There was a resolution submitted by DC Lodge #1 which was rejected. Wednesday came to an end with no casualties, with the exception for the numerous people who wrecked on the city street scooters.

Thursday started with reports, and 2 more resolutions, 1 failed and 1 passed. The day ended early due to no contested elections and only one site choice for 2025.



Retired Law Enforcement Concealed Carry Legal Defense Coverage (CCC)

The FOP Legal Defense Plan also offers separate unlimited legal defense coverage for civil and criminal claims associated with the legal carrying and/or use of a weapon for qualifying retired FOP members. Legal defense costs are covered in full when using a Plan attorney. Coverage is provided to not only those retirees who qualify under LEOSA, but also those retirees who qualify under their own state laws to carry a concealed weapon.

**Eligibility:** You must be an FOP member in good standing and certify that you are legally carrying a firearm within your state under that state's qualifications or meet all of the requirements set forth in LEOSA. In order to qualify, you must be a retired law enforcement officer from a public agency who, among other things, had powers of arrest while employed, retired in good standing after a minimum of 10 years of service (or have a duty disability), and must be legally carrying a concealed firearm or carrying such firearm in one's own home or vehicle at the time of the incident giving rise to a claim. # **<u>POST Retirement Income Fund (PRIF)</u>** <u>Cost of Living Allowance (COLA)</u>

# How is a COLA Calculated for Baltimore County Retirees?

Employee bargaining units, including the FOP, do not negotiate for retirees or for an annual COLA. A COLA is strictly based on the investment earnings of the system.

The calculation process for a COLA for retirees is in Section 5-1-235(c), (d) & (e) of the Baltimore County Code.

(c) As of the end of each calendar year commencing with the year ending December 31, 1989, the increase in the Consumer Price Index to such index as of December 31, 1988, or as of the latest yearend shall be determined, subject to the provisions of subsection (d) of this section. The retirement allowance shall be increased by an amount equal to the increase in the Consumer Price Index, not to exceed three (3) percent. All increases calculated under this section shall take effect July 1, 1990, and on July 1st each year thereafter.

(d) If the funds accumulated from excess investment income in the postretirement increase fund are insufficient to cover the actuarial reserves required to provide the full percentage increase determined under subsection (c) of this section, then the appropriate increase shall be calculated to the nearest one-fourth (1/4) of one (1) percent as such funds will allow but not less than one (1) percent. If the funds are insufficient to provide a one (1) percent increase, then no increase shall be granted. (e) For purposes of this section, "Consumer Price Index" shall mean the Consumer Price Index—All Urban Consumers—United States City Average—All Items (CPI-U), as published by the United States Department of Labor, Bureau of Labor Statistics.

Retiree COLAs are funded through the PRIF Account. (Post Retirement Income Fund) This account is funded through what is called "excess earnings" over the rate of return (ROR) determined by the Board of Trustees and County Council in consultation with the Pension Consultant. The rate is currently 7.875%. This rate is not a market ROR, but the actuarial ROR.

The calculation for the retirement system ROR was historically based on what is called a 5-year smoothing calculation. Using this widely accepted methodology, system losses and gains are calculated in or subtracted from the system over a 5-year period to avoid sharp movements in funding levels and more easily predict annual contribution costs for budgeting purposes.

In 2009, our system and many around the country, were feeling the losses of the great recession. To better control the County Contributions and help the funding status of the system the County and Trustees, under the advisement of the pension consultant, changed the calculation to a 10-year smoothing calculation. This added length greatly affects the calculation of earnings and losses. At the same time, employee bargaining groups throughout the county started contributing more from their pay. Currently new employees pay up to 10% into the system.

In 2018 the methodology for the calculation of a COLA was changed from the 10-year smoothing calculation to the 8-year geometric average rate of return for the last 8 calendar years. If the geometric average rate of return for the last 8 calendar years is lower than 7.875%, there are no excess investment earnings for the year to fund the PRIF.

Currently the system is approximately 63% funded at \$3,285,066,542. The cost of a 1% COLA for county retirees is \$19,852,856. The cost of a maximum COLA of 3% is \$59,558,569. In 2005 the cost of a 1% COLA was \$9,300,000 and a 3% COLA was \$27,900,000.
