THE PRESIDENT'S MESSAGE

HEALTH CARE INITIATIVE

As many of you are aware, health care is negotiated differently from your wages and benefits. Many years ago, the county established the Health Care Review Committee, which consists of six labor groups and the management group. Collectively, these seven groups bargain with the County. The problem is that since this is separate from wages, benefits and working conditions, binding arbitration does not apply.

Binding arbitration allows for a neutral, third-party person to decide on negotiated proposals. The arbitrator hears testimony and receives evidence from both sides before rendering a decision. The arbitrator must always consider the "ability to pay" by the county, thus ensuring a fair verdict. Since health care has not been subject to binding arbitration, it has been difficult to make progress in developing a solid Baltimore County health care system. The county often agrees with the committee's proposals, but they are not bound and many times take no-action.

FOP Lodge 4 has asked the Health Care Review Committee to pursue a Charter Amendment to the Baltimore County Charter that authorizes the Baltimore County Council to provide for a system of binding arbitration in health care negotiations. This is a big project with a deadline of August 1st. This will benefit all Baltimore County employees and retirees. Having a fair system that will result in great health care will be a recruitment incentive and retention tool for all of the agencies in the county. It can also provide better programs and potentially bring some relief to Baltimore County retirees.

More information will be forth coming on the process to achieve this goal.

Donation Review: Ryan Franks - The committee brought forth 4 motions to review, 1) a donation to the each, the East Central Alarms and a separate to Box 234 - the West Central Alarms. 2) a donation to purchase t-shirts for baseball camp run by Brother McElfish. 3) a donation to pay for Kona Ice for the Save Our Youth (SOY) bike ride, sponsored by Brother Kawahn Young. 4) a donation to FOP Lodge 111 for a memorial fund set up for Deputy Hilliard.

Grievance: Dave Sweren - 1)The class action for COVID days is still open. 2) Substitution pay was heard at step 3 on May 24, 2022. Judge Murphy ruled in our favor, but the County Office of Law has advised that this will be going to arbitration. 3) There are still more payroll issues. 4)Sub, OT, Steps and promotions was heard at step 2 on June 18, 2022, waiting on decision. 5) CIB Interview process was heard at step 3. The Administrative Law Judge ruled that a member should not have previously adjudicated matters held against them, unless specified. 6) National Guard Grievance - lost at OAH, appeal set for July 26, 2022. Grievance was filed for Change of code for military time.

Health Care: Mike DiCara - Met June 15, 2022 and discussed with the County a proposal to move pre and post 2007 employees to 1 premium schedule. The County discussed moving excess funds to OPEB account.

Legal Advisory: Dave Sweren - There are still 4 members at home waiting trial boards and or termination.

Legislative: Dave Folderauer - Your ability to expunge records expires on July 1, 2022.

Merchandise: Donna Patterson - We have the Maryland FOP shirts, with Baltimore County Lodge 4 on them. The only color we have available is BLACK.

Negotiations: Dave Folderauer - We are putting a team together.

Pension: Don Patterson - At the June 14, 2022 Pension Board of Trustees meeting, we approved 51 total retirements, 27 from the Police Department

Policy Review: Dave Sweren - Reviewed the Use of Force Policy and sent back many suggestions for changes. The MPIA policy is still being worked on.

Political Action: Dave Folderauer - The Committee held candidate interviews on June 9 and June 21, 2022. The following recommendations were brought forth, 1) to endorse Doug Gansler for Governor in the Primary, passed unanimously. 2) to endorse Wade Kach for Council, passed unanimously. 3) to endorse Johnny Ray Salling for State Senator, passed unanimously. 4) to endorse Dana Stein for Delegate, passed 10-4. 5) to endorse Jon Cardin for Delegate, passed 10-4. 6) to endorse Robin Grammar for Delegate, passed unanimously. 7) to endorse Ric Metzger for Delegate, passed unanimously. 8) to endorse Nino Mangione for Delegate, passed unanimously. 9) to donate \$1000 to campaign of Todd Crandell. 10) to donate to campaign of Kathy Szeliga, passed unanimously. 11) to donate to campaign of Scott Shellenberger.

Social Media: Chris Hodnicki - We are out on every platform. Keep using the APP.

Promotional Process: Mike DiCara - There were 2 protest questions on the Corporal test: one, the review found to be correct and the other everyone received credit.

NEW OR HELPFUL INFORMATION

Address Changes: As we continually receive numerous returned Fourwords and other mailings, and returning the address change requires postage from our Membership, we're going to move forward with address changes/updates via email. The preferred email for address changes will be: office@foplodge4.org

Please include; your NAME, your ADDRESS, your EMAIL address, and your TELEPHONE number.

Fourword - Electronic version: The Fourword is available in both a mailed version and an electronic version, which is published to the APP. At times, the electronic version may contain additional images, info or news, that isn't practical to include in the print version. As we navigate through changes in technology, and bylaws, we may have the ability to limit mailed versions of the Fourword, but cannot easily do so at this time.

Payroll: The Payroll Department acknowledges the issues that have been worked through and they continue to be amenable to assisting us work through any that arise. A few point that may help in avoiding delayed payment in the future include:

1. Don't "boilerplate" your OT or CL slips. This would decrease errors, as each slip should be unique in nature, just as the reason for the OT is.
2. Make sure slips are complete and signed by all necessary personnel, then scanned and forwarded to Payroll in the manner prescribed by Payroll. If it's easier for them to categorize, it's quicker for them to pay.
3. When multiple slips, from multiple Officers are generated from one event, coordinate with Payroll to ensure they are filled out accurately and consistently, across all involved members.
