

THE PRESIDENT'S MESSAGE

HISTORIC MOTION

On May 23, 2022, at our General Business Meeting, a member made a motion to notify the County Executive that the membership has lost faith in the leadership of Chief Hyatt. That motion was seconded, which allowed for a discussion. After that discussion, a vote was called for, resulting in the motion passing unanimously.

There were 128 members of Lodge #4, who signed-in have their attendance recognized, with a couple dozen who elected not to do so, due to fear of retaliation. A head count was conducted with a finding of over 150 of our members in attendance. Only 26 of those in attendance were identified as retirees.

During the discussion that took place over the motion, numerous associated topics were brought forward by our members. At the conclusion of the discussion, those present were permitted three options: Aye, No, or Abstention. The "Aye" votes, in favor of the motion, were resounding and there were zero votes voiced during the call for "No" or "Abstention". This vote was unanimous.

Since that time, both the Chief and the County Executive have refused to acknowledge our voting members. The Chief called them a distraction. The Executive dismissed this as mostly retirees. Both of these responses are inaccurate and disappointing to say the least.

Every voice should be heard. Every voice should be recognized. We have invited the County Executive to attend the next Business Meeting in June. There, he will have the opportunity to hear form our membership himself.

In the meantime, we will continue to work with both the Chief of Police and the Baltimore County Executive in the best interests of the members of the Fraternal Order of Police.

The regular monthly meeting of the Baltimore County Fraternal Order of Police was held at 7:30 P.M., on Monday, May 27th at, at the Holiday Inn – Timonium. President Folderauer was present, in chair, as was Secretary Patterson. A motion was made by Brother Scally, to accept the minutes from our April meeting. This was seconded by Brother Speed, and approved with no discussion. Said minutes have been posted to the Lodge #4 App.

- A proposal was submitted to purchase a business membership at the Guntry Club.

<u>Donation Review</u>: Ryan Franks - There were three requests for donations:

All motions were passed.

Expenditure Review: Doug Jess - We reviewed expenditures for October, November, and December of 2021. All were found to be in order.

Grievance: Dave Sweren - We're still waiting for a response on the calculation of National Guard Time. The Sergeant Oral Interview was won at Step 3, and we are awaiting the County's remedy. The CIB Interview process is now at Step 3, pending the hearing/meeting. We prevailed in the Class Grievance over Substitution Pay and are awaiting the County's response.

Healthcare: Mike DiCara - The RFP has been completed, but we can't release the results yet.

Pension: Don Patterson - At the May 10, 2022 Pension Board of Trustees meeting, the Board approved 38 Total retirements, including 8 from the Police Department.

Policy Review: Dave Sweren - President Folderauer and Second Vice President Mike DiCara are working on the MPIA request policy.

Political Action: Dave Folderauer / Mike DiCara - We're working on interviewing candidates for County Executive, County Council and local Delegates and Senators.

PAC questionnaires have been distributed to candidates for County Executive, open County Council seats, and numerous General Assembly seats. The Political Action Committee met on May 18th and May 23rd to review these responses and conducted interviews with several of the interested candidates. The following motions were discussed and passed by the committee:

- 1) Motion to endorse Senator Chris West (R-District 42) for re-election.
- 2) Motion to donate \$500 to Senator Chris West for an event being held on June 16th.
- 3) Motion to endorse Senator Kathy Klausmeier (D-District 8) for re-election.
- 4) Motion to donate \$500 to Senator Kathy Klausmeier's campaign.
- 5) Motion to endorse Delegate Kathy Szeliga (R-District 7A) for re-election.
- 6) Motion to endorse Councilman Izzy Patoka (D-2nd District) for re-election.

Each motion was passed by the EBOD and the General Membership.

More interviews and possible endorsements will take place in June.

REUNION

Annually, on May 15, our Nation celebrates National Peace Officers Memorial Day, as declared by President Kennedy in 1962. This year, in Washington D.C., we commemorated our Fallen Heroes with events on May 15, including, "Stand Watch for the Fallen" and the annual "Wreath Laying Ceremony". Locally, at this time every year, we honor our Baltimore County Fallen Officers, including Corporal Samuel Snyder.

On August 10, 1983, Corporal Snyder sacrificed not only his life, but his place in life as husband to Helen and father to Joel. After responding with fellow Officers to a disturbance at Loch Raven Blvd and Joppa Rd, Corporal Snyder was wounded by gunfire from the Suspect. After a ten day battle in the hospital, sadly, he succumbed to his injuries on August 23, 1983, at 71.

This year, in perhaps a beautiful twist of irony or fate, on the day we celebrated the loss of our Officers, Helen Snyder passed and was reunited with her beloved Samuel, to celebrate with each other in eternity. Together, they will keep watch, not only over all of us who remain on the job, but over the family that they began decades ago, which now includes; their son Joel and his wife Debbie; grandchildren Amy Gallagher and Jason Snyder (and wife Courtney); greatgrandchildren Samantha and Colin Gallagher and Maya and Jacob Snyder.
