President's Message

We are currently working through Police Human Resources (PHR) on pay issues involving some of our members. A few of these pay issues go back a several years. We have identified members who have been overpaid and those who have been underpaid. One of the causes relates to the reclass settlement when members were not moved correctly under the prior PHR administration. We are working with the current administration to correct those members' pay and calculate any retro payment owed to them. For those members who were overpaid, section 6.17, Overpayments, in our MOU only allows the county to recover overpayments that occurred within twelve pay periods since the county provided notice to the employee. We have found these errors to be in County OHR.

Also, affecting a few of our members, the default weekly hours were set at thirty-five instead of forty. The employees were still receiving the correct biweekly pay, but technically their hourly rate was incorrect. They were paid the correct salary but based on thirty-five hours worked. Therefore, any OT hours were paid at a higher hourly rate. We are working with PHR to make those corrections.

Please check your weekly pay stubs for the correct overtime hours paid, and the correct hourly rate of pay each week.

We have also had another retiree almost have their leave pay out incorrectly placed in the wrong account. This retiree submitted all the proper paperwork to the County Payroll Office and received copies of that paperwork. We were able to discover the error and stop the transaction in time to prevent this from happening. I communicated this to the Deputy Administrative Officer and the Budget Director and informed them that this type of error was unacceptable, and this is the sixth time this has occurred. They communicated back to me this was a human error and not a Workday problem. They were addressing it as a personnel matter.

Please personally deliver your retirement paperwork to the Pension office and have them review it for accuracy. Get copies and a receipt from the person who accepted it. Afterwards, proceed down the hallway to the Budget and Payroll Office to hand in any investment paperwork for DROP (Nationwide or other investment firm), and any other banking institution you may be directing funds to be sent after your retirement. Have it reviewed for accuracy. Get copies and a receipt from the person who accepted it.

Please contact the lodge as soon as possible if an error is discovered. We must move on this as quickly as possible to stop the transaction.

Amendment to the Constitution and Bylaws of FOP Lodge 4

Whereas: Currently the duties and responsibilities of the Negotiation Committee are not addressed in the Lodge 4 Constitution and Bylaws.

Whereas: Committee members are not required to be elected representatives.

Whereas: The FOP Lodge 4 EBOD currently has no involvement in the decision to waive binding arbitration during contract negotiations.

Whereas: The Lodge 4 EBOD are elected by the membership to represent the best interests of the membership.

Therefore: Article V (Duties of Committees) of the Bylaws of the Lodge 4 Constitution will be amended by adding a section (11) for the Negotiations Committee.

Bylaws Article V Section 11 Negotiation Committee:

- A. In the case that an agreement is reached between the committee and the County to extend the deadline for binding arbitration, that agreement must be presented to the EBOD in writing for notification.
- B. In the case that the committee wishes to waive or allow the deadline to pass for binding arbitration to be used, the EBOD will be notified and must approve this waiving/expiry.
- C. The committee recommendation to proceed to binding arbitration must be approved by the EBOD.

This proposal is submitted by Douglas Jess to President Dave Rose on the 13th day of May, 2024.
